INDEX OF INDUSTRIAL PRODUCTION FOR THE MONTH OF SEPTEMBER, 2019

The Directorate of Economics and Statistics, Government of Manipur has released the Quick Estimates of Index of Industrial Production (IIP) for Manipur with base year 2011-12 for the month of September, 2019. IIP is compiled using primary data collected from the industrial units/factories by the Directorate for the manufacturing sector and the website of Central Electricity Authority for the electricity sector.

2. IIP measures the industrial performance during a period compared to a fixed period i.e., base year 2011-12=100 of an economy. At the State level, IIP reflects the industrial development of a state.

3. The scope of IIP constitutes the mining, manufacturing and electricity sectors. However, data from the mining sector in Manipur is not available and so only manufacturing and electricity sectors are considered for the compilation of IIP.

4. The General Index for the month of September, 2019 stood at 39.9 as against 164.4 in September, 2018 showing a negative growth of (-) 75.7 %.

5. The Indices of Industrial Production for the Electricity and Manufacturing sectors for the month of September, 2019 stood at 17.2 and 233.1 respectively, with the corresponding growth rates of (-) 89.9 % and 94.2 % as compared to September, 2018 (Statement I of the Annexure).

6. The industry group 'Manufacture of food products' has shown the highest positive growth of 317.1 % and 'Manufacture of chemicals and chemical products' has shown the lowest growth with 2.2 % growth in September, 2019 for the Manufacturing sector (Statement II of the Annexure).

7. Along with the Quick Estimates of IIP for the month of September, 2019, the indices for August, 2019 have undergone the final revision in the light of the updated data received from the source agencies. The General Index for August, 2019 has been revised to 119.7 from 119.8.

8. The Cumulative Index for April - September, 2019 for electricity sector stood at 77.3 showing a negative growth of (-) 49.6 % and manufacturing sector stood at 231.1 showing a positive growth of 99.6 %. The Cumulative General Index for April - September, 2019 stood at 93.4 showing a negative growth of (-) 37.5 %.

9. The statistical tables showing the month-wise (Statement I) and NIC 2 Digit level IIP (Statement II) of Manipur for the month of September, 2019 are at Annexure.

2. September, 2019 indices are Quick Estimates and will undergo revision at the time of release of October, 2019 index on Friday, 28th February, 2020.
3. The negative growth of (-) 75.7 % in the General Index for the month of September, 2019 which stood at 39.9 as against 164.4 in September, 2018 is due to the sharp fall in power generation from 74 MU in September, 2018 to 8 MU in September, 2019 as power generation in Manipur is mainly through hydro power plants.
